Chairman Mel Powell called the meeting to order at 5:30 P.M.

Reappointment Members (WIOA Board) Mel Powell & Clay Reid – 3 year term 2026

Commissioner Jamie Handley made a motion to reappoint Chairman Powell and Commissioner Clay Reid. Commissioner Alfonza Hall seconded and this carried unanimously.

Resolution for Sheriff Special Election- Tuesday, November 7th, 2023

County Attorney Toni Sawyer explained that this special election is being held to fill the rest of Sheriff Robert Rodger’s term which ends on January 1st, 2025. The special election will be held November 7th, 2023 and will have a polarity ballot, which means whoever receives a vote of 50.1% will become the new Sheriff. If one candidate does not receive more 50.1% or more then there will be a runoff election held. The qualifying date for this election is September 25th-29th and a notice will be sent to the Cordele dispatch two weeks before. The qualifying fee is set at \$562.91. Commissioner Clay Reid made a motion to accept the qualifying dates and fees for the special election. Commissioner Jamie Handley seconded this motion and carried unanimously.

Resolution for SPLOST Election- Tuesday, November 7th, 2023

County Attorney Toni Sawyer explained that the current SPLOST will expire in March 2024.

The new SPLOST will start collecting in April 2024 with the approved projects. Commissioner

Jamie Handley made a motion to accept the resolution for the new SPLOST election.

Commissioner Alfonza Hall seconded this motion and it carried unanimously.
