### 2. Call to Order

Chairman Jamie Handley called the meeting to order at 5:30 p.m.

### 3. Invocation and Pledge

- The invocation was delivered by Commissioner Jowan Johnson.
- All present stood and recited the Pledge of Allegiance.

# 4. Silicon Ranch Project II - Presentation and Q&A

Chairman Handley opened the meeting by noting that the purpose of this session was to address questions related to Silicon Ranch Project II, located on property previously considered for a single project. He stated that some questions may also relate to Project I, and Mr. Conner Echols was present to provide clarity.

## Overview by Silicon Ranch

Mr. Echols introduced himself and provided an overview of Silicon Ranch's mission, community investment philosophy, and long-term approach of purchasing land rather than leasing. He noted that unlike many solar companies, Silicon Ranch typically maintains ownership of the land beyond the life of the project.

# **Summary of Questions and Responses**

- Land Ownership & Sale (Question by Jerek Walton)
   Mr. Echols addressed the company's value in owning the land and emphasized Silicon Ranch's intent to remain a long-term community partner.
- Bankruptcy Concerns (Question by Commissioner Hair)
   Mr. Echols explained that protections are included in the Memorandum of Understanding (MOU) to safeguard the county in such an event.
- Tax Abatement & PILOT Payments (Wilcox County School)
  Attorney Jeff Chestnut described how the Wilcox County Development Authority issues the bonds for

project equipment such as solar panels.

The county and school system will receive PILOT (Payment in Lieu of Taxes) revenues, replacing traditional property taxes on the equipment (solar panels).

## Storm Damage to Solar Panels (Question by Commissioner Powell)

Mr. Echols confirmed that damaged panels would be replaced promptly to maintain the output required under the MOU.

# • Impact on School System Funding

The Wilcox County School Board raised concerns regarding federal funding impacts.

Mr. Chestnut explained that PILOT payments do not negatively affect federal funding formulas, and land value changes are expected to be minimal.

## • Project Timeline and Capacity

- Project I: Construction expected to begin December 2025, producing 90 MW.
- o Project II: Expected to begin 2027, producing 50 MW.

### • Environmental and Site Work (Question about third-party land work)

Mr. Echols noted that extensive environmental and regulatory testing is required before construction begins.

### • Sheep Grazing Land Management

Silicon Ranch discussed its investment in sheep grazing as a long-term, sustainable vegetation management strategy.

### • Job Fairs and Local Employment

Mr. Echols said a job fair is planned to support 100-200 positions across Projects I and II over the construction period.

# 5. Consideration of Memorandum of Understanding (MOU) - Silicon Ranch Project II

Chairman Handley thanked Silicon Ranch and all participating boards for their attendance and input.

A motion was made by Commissioner Jowan Johnson to approve the Memorandum of Understanding for Project II, to commence following the activation of Project I.

  - No: Commissioner Powell, Vice Chairman Reid (Vice Chairman Reid abstained from support due to owning adjacent property)
